### FUNDRAISING TERMS

1. **PROFIT:** Your organization will earn a profit according to your sales volume in both options A and B as explained in chart A – Sales Volume/Profit and chart B – Sales Volume/Profit. With option C your profit will be a flat percentage of 20% for the duration of your fundraiser.

2. **SHIPPING:** Your organization will receive free shipping when minimum specified sales volumes are met as explained in applicable Sales Volume/Profit chart. Free shipping will occur either via Kylie's Canine Treats or Kylie's chosen common freight carrier. Shipping charges are billed directly to customer with orders placed via online fundraising option C.

**3. PAYMENTS:** Your organization will be responsible for collecting full payment for each customer order through options A or B when it is placed. You will submit one payment to Kylie's. You will retain your organization's profit and submit the balance collected to Kylie's at the time you submit the fundraising orders. To calculate your organization's profit, add up the order totals before sales tax was added (where applicable) and apply the discount rate from applicable Sales Volume/Profit chart. This is the profit to be retained. Send the balance of the funds (which will be the remainder of the order product totals plus the entire amount of any sales tax collected) to Kylie's. Your payment to Kylie's will be made at the time the orders are placed by cashier's check, your organization's check or credit card. Add 1.5% of gross sales to total due payable to Kylie's when using credit card for payment.

Your organization will have little direct involvement in option C. Your profits depend on your organizations advertising abilities. Your profit will be made payable via check from Kylie's Canine Treats upon completion of fundraiser. Residual checks will be mailed monthly.

**4. BONUS PROFITS FOR YOUR CUSTOMER'S REORDERS:** Kylie's will contribute to your organization the sum equal to 5% of the merchandise totals of reorders placed through our online store by customers who originally ordered through your completed fundraising project. The duration of this residual bonus income is for one year from close of fundraiser. A completed fundraiser must occur each year for continuous ongoing residual income. Your proceeds from those customers' reorders will be sent by check monthly to your organization through its designated representative.

**5. PROMOTIONAL MATERIALS:** Kylie's will provide a color flyer and order forms for usage by the participants (sales agents) during the fundraising drive efforts. The flyer shows scale pictures, descriptions and ingredient/nutritional data to be used as your sales tool. Please reasonably estimate your number of participants so Kylie's can provide the appropriate number of flyers and order forms. More forms can be requested at any time. A sample packet containing completed materials replicating a completed fundraiser is included with shipment for reference. Note the master tally form is only utilized with option B.

**6. DELIVERY:** Option A delivery 2 - 3 weeks following the date we receive your orders and payment. Option B delivery date is 1-2 weeks. We will bake your order fresh when the order is received. Option C orders are shipped directly to customer from Kylie's Canine Treats.

**7. REFUND POLICY:** Because Kylie's Canine Treats are freshly baked to order for maximum flavor and freshness, dog treats cannot be returned. Orders may not be cancelled after being placed, and Kylie's offers no refunds on any fundraising order after the order has been placed.

**8. LIABILITY:** Kylie's Canine Treats is not responsible for the results of your fundraiser as each fundraiser project is unique and dependent upon the efforts of the organization and its participants. Kylie's Canine Treats are safe for animal consumption under proper supervision, but are not a replacement for normal feeding of pets. Kylie's Canine Treats are not recommended for human consumption. Kylie's is not responsible for any adverse results from unsupervised or improper consumption of Kylie's Canine Treats.
